Subject: Tentative Order No. R9-2016-0127, An Order Rescinding Orders Nos. 86-24, 88-44, and 94-46

Messrs. Davidson and Kaveney, and Ms. Graham-Wakoski:

This letter serves to inform you that the California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) will consider adoption of Tentative Order No. R9-2016-0127 (Tentative Order) at its scheduled meeting on Wednesday, August 10, 2016. The Tentative Order, if adopted, would rescind the following Waste Discharge Requirements Orders:

1. Order No. 86-24, *Waste Discharge Requirements for Discharge of Domestic Wastewater from the Prince of Peace Abbey, San Diego County.*
2. Order No. 88-44, *Waste Discharge Requirements for American Adventure, Butterfield Country Recreational Vehicle Resort, Riverside County.*¹
3. Order No. 94-46, *Waste Discharge Requirements for the County of Orange General Services Agency, Los Pinos Forestry Camp Orange County.*


The August 10, 2016 meeting will begin promptly at 9:00 AM and will be held at the following location:
