Joann,

Thanks for your kind support towards renewing the permit application.

As we were going through the Tentative Order, we have come across a reporting schedule that need an amendment.

Please note the yellow circle in the attachment. It is on page 57 of the Tentative Order. The rational for this request as we mentioned in our meeting with the water board at RWQCB office, is that we have many agency report deadlines for the month of January and July.

Hence we are requesting an additional month for semiannual report of January to June. This report is vest and extensive in reporting parameters in SMR reporting tool.

We have been granted two months of reporting time for July to December report. But for January to June report, the schedule is just one month. We want it to be consistent for both semiannual reports.

Hence SDG&E is requesting the agency to amend the due date for January to June to be September 1st instead of August 1st. Since there is additional time for comments, we would like to use this window of time to make this request.

Please review and let us know the decision. Your help is appreciated.
