INC**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), finds that:

**Background**

1. On March 16, 2015, the San Diego Water Board adopted Order No. R9-2015-0009 (NPDES No. CA0109142), establishing waste discharge requirements for Continental Maritime of San Diego (Discharger) to discharge industrial storm water into San Diego Bay.
2. By letter dated August 6, 2018, the Discharger notified the San Diego Water Board of a legal company name change to Huntington Ingalls (HII) San Diego Shipyard, Inc. By email dated October 23, 2019, the Discharger further revised the requested name change to HII San Diego Shipyard, Inc.

**Purpose of this Order**

3. The San Diego Water Board is amending Order No. R9-2015-0009 to change the Discharger's name to HII San Diego Shipyard, Inc.

**Legal Authorities**

4. Section 122.41(l)(3) of title 40 of the Code of Federal Regulations authorizes the modification of Order No. R9-2015-0009 to change the name of the Discharger. Section 13263(e) of the California Water Code provides that the San Diego Water Board may, upon application by any affected person, or on its own motion, review and revise waste discharge requirements.
5. Order No. R9-2015-0009 is not being reopened for any other purpose than the revisions contained herein. Except as contradicted or superseded by the findings and directives set forth in this Order, all of the previous findings and directives of Order No. R9-2015-0009 shall remain in full force and effect.

### California Environmental Quality Act

6. This action is exempt from the requirement for preparation of environmental documents under the California Environmental Quality Act (Public Resources Code, division 13, chapter 3, section 21000 et seq.) in accordance with section 13389 of the Water Code.

### Public Participation

7. The San Diego Water Board has notified all known interested parties of its intent to adopt this Order and has provided them with an opportunity to submit their written comments and recommendations.
8. The San Diego Water Board in a public meeting heard and considered all comments pertaining to adoption of this Order.
9. Any person aggrieved by this action of the San Diego Water Board may petition the State Water Resources Control Board (State Water Board) to review the action in accordance with Water Code section 13320 and California Code of Regulations, title 23, sections 2050 et seq. The State Water Board must receive the petition by 5:00 p.m., 30 days after the adoption date of this Order. Revise Tentative Order pages F-27 through F-29, Attachment F, Section VIII is modified in relevant part as follows:

“...The San Diego Water Board has considered the issuance of WDRs that will serve as an NPDES permit for Continental Maritime of San Diego and following transfer of permit responsibility, coverage, and liability in December 2019, for HII San Diego Shipyard, Inc. As a step in the WDR adoption process, the San Diego Water Board staff developed tentative WDRs and encouraged public participation in the WDR adoption process...”

“...D. Order No. R9-2019-0220 Amending the Order  
On November 1, 2019, the San Diego Water Board provided public notice of its intent to consider adoption of an amendment to the Order at a December 11, 2019 public hearing and provided a period of at least thirty days for review and comment on the Tentative Amending Order No. R9-2019-0020 (Amending Order). The Notice of Public Hearing and Opportunity to Comment (Notice) and the Amending Order were posted on the San Diego Water Board website for at least the duration of the 30-day comment period. A copy of the Notice and the Tentative Amending Order were also sent by email dated November 1, 2019 to the Discharger and all known interested agencies and persons. Notice of the public hearing on the Amending Order was also provided in the Meeting Notice and Agenda for the December 11, 2019 San Diego Water Board meeting, which was posted on the San Diego Water Board website more than 10 days prior to the meeting. The public also had access to the agenda and any changes in dates and locations through the San Diego Water Board’s website at <https://www.waterboards.ca.gov/sandiego/>

The Discharger and interested persons were invited to submit written comments concerning the Amending Order as provided through the notification process. Comments were due either in person or by mail to the Executive Officer at the San Diego Water Board at 2375 Northside Drive, Suite 100, San Diego, CA 92108 or by email to [sandiego@waterboards.ca.gov](mailto:sandiego@waterboards.ca.gov). The San Diego Water Board provided written responses to all timely received public comments on the Amending Order and posted the response to comments document on the Board’s website in advance of the public hearing date.
