Hi Brandon,

Thank you for providing the outline of facilities and their status. I agree with your explanation on each.

According to our records the two OWTS for the Lower Otay Lakes County Park were installed in May, 2007 through the County's permitting process. Both systems were issued under permit code LSTP-7794. If the permit information is sufficient for your records, I would consider the facility to be regulated under the LAMP once the WDR is rescinded.

I'll reach out to you when we receive Barbara's submittal on Mussey Grade Village to confirm the Board's expected time line of completing intermediate repairs.

Hey Craig,

I am emailing you regarding all the facilities that we are currently working on together and their statuses:

1. **Tecate Truck Inspection**
 - a. WDR scheduled to be rescinded in May 2019
 - b. No further action needed on your end

2. Lower Otay Lakes

- a. We have discussed this facility and I recently inspected to confirm it is eligible for LAMP enrollment
- b. I will cc you on inspection report going out soon
- c. Please provide an email confirming it is eligible for enrollment once you have gone through your process
- d. Contact info for Park: Lauren Raduc (858) 354-2240, lauren.raduc@sdcounty.ca.gov

3. Mussey Grade Village Park

- a. Barbra Bradley, their consultant, has been in touch with both the county and water board about the repairs/upgrades to the OWTS
- b. The county will be over seeing the interim repair to the septic system (does not need LAMP enrollment) just initial approval and construction oversight
- c. Ms. Bradley will submit a ROWD for the upgraded package plant to be installed, which will be approved and regulated by the Water Board

4. Fallbrook Kamp Retreat

- a. Inspection report being drafted and sent out soon will give the option to close dump station and process with LAMP enrollment or continue under water board's regulation
- b. I will cc you on inspection report

Please let me know if any of this information does not seem correct or if I am miss understanding anything you have said. Thank you for your help and cooperation in this effort.
