# EXECUTIVE OFFICER SUMMARY REPORT September 11, 2019

#### ITEM 5

#### SUBJECT

Informational Item: Update on Current Research by the Southern California Coastal Water Research Project (SCCWRP). (David Barker)

#### STAFF RECOMMENDATION

This is an informational item and the Board will not take an action.

#### **KEY ISSUE**

SCCWRP staff will provide the Board with an overview on the status of SCCWRP research on a variety of projects currently being worked on to improve management of aquatic systems in Southern California and beyond.

#### PRACTICAL VISION

San Diego Water Board engagement in the research being conducted by SCCWRP supports the Practical Vision<sup>1</sup>, by increasing the Board's expertise in the application of new technological approaches that are allowing advances in the efficiency, precision and reach of water quality management strategies and tools.

#### DISCUSSION

SCCWRP is a public research agency <sup>2</sup> that develops and applies next-generation science to improve management of aquatic systems in Southern California and beyond. Since its founding in 1969, SCCWRP has been developing strategies, tools and technologies that the region's water-quality management community relies on to more effectively protect and enhance the ecological health of Southern California's coastal ocean and watersheds.

SCCWRP annually prepares a Research Plan Executive Summary <sup>3</sup> to convey the broad thematic areas around which SCCWRP's research is focused, and to provide an overview of the major projects being worked on to advance those thematic areas. SCCWRP's presentation will include comments on a variety of research projects currently underway including:

- 1. Pinpointing sources of fecal contamination;
- 2. Rapid microbiological testing methods for measuring recreational water quality;
- 3. Antibiotic resistant bacteria in sewage effluent;
- Causal assessment of biological health in streams;

- 5. Evaluating resiliency of coastal wetlands to sea level rise;
- 6. Assessing storm water best management practices (BMPs) effectiveness; and
- 7. Ocean model for predicting effects of ocean acidification and hypoxia.
