The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0088, *An Order Rescinding Order No. 86-32, An Order Prohibiting the Discharge of Wastes Beyond the Limits of Lands Owned or Controlled by Color Spot Foliage Inc., Near Fallbrook, San Diego County* (Tentative Order), for public review and comment. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday June 16, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
