EXECUTIVE OFFICER SUMMARY REPORT

SUBJECT

Consideration of Tentative Order No. R9-2020-0135, *An Order Rescinding Order No. 94-13, Waste Discharge Requirements for Ms. Christine Stanley, Pinezanita Trailer Ranch, San Diego County* (Tentative Order No. R9-2020-0135). (Brandon Bushnell)

STAFF RECOMMENDATION

Adoption of Tentative Order No. R9-2020-0135 is recommended.

KEY ISSUES

Tentative Order No. R9-2020-0135 (**Supporting Document 1**), if adopted, rescinds Order No. 94-13, *Waste Discharge Requirements for Ms. Christine Stanley, Pinezanita Trailer Ranch, San Diego County* (Order No. 94-13). The onsite wastewater treatment systems (OWTS) at the Pinezanita Trailer Ranch (Facility), owned and operated by Mr. Tom Stanley (Discharger), will be regulated under State Water Resources Control Board Order WQ 2014-0153-DWQ, *General Waste Discharge Requirement for Small Domestic Wastewater Treatment Systems* (General Order).¹

PRACTICAL VISION

Tentative Order No. R9-2020-0135 is consistent with the Strategizing for Healthy Waters chapter of the *San Diego Water Board Practical Vision*.² The use of statewide permits, like the General Order, help the San Diego Water Board focus staff resources on larger projects and facilities within the region that pose a greater threat to water quality. Additionally, enrolling dischargers in the General Order maintains consistent regulation of small domestic wastewater systems throughout the State.

DISCUSSION

The Facility is located at 4446 Highway 49, Julian in San Diego County (**Supporting Document 2**). San Diego Water Board staff conducted an inspection of the Facility and did not observe any violations of the requirements specified in Order No. 94-13.

San Diego Water Board staff reviewed the Discharger's Report of Waste Discharge for enrollment of the Facility in the General Order, and the requirements specified in Order No. 94-13. San Diego Water Board staff determined the Facility OWTS is eligible for enrollment in the General Order. Furthermore, Order No. 94-13 is outdated and is not as protective of water quality as the requirements specified in the General Order. Implementation of the General Order provides a more appropriate, consistent, and streamlined statewide approach to regulating small domestic wastewater treatment systems. Discharges from small domestic wastewater treatment systems have certain common characteristics, such as similar constituents, concentrations of constituents, disposal techniques, flow ranges, and require the same or similar treatment standards. While the Discharger may request to be regulated under individual waste discharge requirements, the Facility's enrollment in the General Order allows the San Diego Water Board to effectively and efficiently regulate discharges from small domestic wastewater treatment systems, while prioritizing the agency's limited resources.

SIGNIFICANT CHANGES

The significant differences between the General Order and Order No. 94-13 are:

1. Order No. 94-13 includes individual waste discharge requirements for the Facility and the General Order regulates small domestic wastewater facilities statewide.
2. The monitoring required by the General Order is less stringent than the monitoring included in Order No. 94-13, however the monitoring and reporting program required by the General Order is more appropriate and consistent with facilities of similar size and discharge across the State.

COMPLIANCE RECORD

A total of three staff enforcement letters have been issued to the Facility for the following violations of Order No. 94-13:

- Failure to submit the 1995 Annual Monitoring Report by the specified due date.
- Failure to submit completed Annual Monitoring Reports for 2003 and 2006.

Since the issuance of a Staff Enforcement Letter in July 2009, no violations of Order No. 94-13 have occurred.

PUBLIC NOTICE

Notification of this action was sent to the Discharger and known interested parties by mail on August 13, 2020 (**Supporting Documents 3 and 4**). Additionally, Tentative Order No. R9-2020-0135 was posted on the San Diego Water Board website on August 13, 2020. No comments were received during the public comment period. These actions satisfy the 30-day public notification and comment period requirements of Water Code, section 13167.5.
