The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0175, *An Order Rescinding Order No. 94-21, Waste Discharge Requirements for Mr. Charles J. Williams, Champagne Lakes RV Resort, San Diego County* (Tentative Order), for public review and comment. to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Friday, July 31, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
