The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2020-0177, *An Order Rescinding Order No.* 95-89, Waste Discharge Requirements For Thomas Sarrantos, Pair-A-Dice Mobile Home Park, San Diego County (Tentative Order), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Order at its regularly scheduled meeting on **September 9, 2020**. The Tentative Order, if adopted, will rescind Order No. 95-89, Waste Discharge Requirements for Thomas Sarrantos, Pair-A-Dice Mobile Home Park, San Diego County (Order 95-89).

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Tuesday, September 15, 2020,** will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday, September 15, 2020**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
