**REVISED TENTATIVE ORDER NO. R9-2021-0205  
AMENDING**

**ORDER NO. R9-2019-0167 as amended by Order No. R9-2020-0191  
NPDES NO. CA0109347**

**WASTE DISCHARGE REQUIREMENTS  
FOR THE MARINE CORPS BASE, CAMP PENDLETON  
SOUTHERN REGIONAL TERTIARY TREATMENT PLANT AND  
ADVANCED WATER TREATMENT PLANT AT HAYBARN CANYON  
DISCHARGE TO THE PACIFIC OCEAN THROUGH THE OCEANSIDE OCEAN  
OUTFALL**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), finds that:

**Background**

1. The Marine Corps Base, Camp Pendleton (MCBCP or Discharger) is the owner and operator of the Southern Regional Tertiary Treatment Plant (SRTTP) and the Advanced Water Treatment Plant at Haybarn Canyon (AWT) (separately and collectively referred to herein as Facility). The Facility is described in Section II of Order No. R9-2019-0167.
2. Order No. R9-2019-0167 was adopted by the San Diego Water Board on February 12, 2020 and amended by Order No. R9-2020-0191 on August 12, 2020. Order No. R9-2019-0167 is a National Pollutant Discharge Elimination System (NPDES) permit which establishes waste discharge requirements for the SRTTP and AWT for the discharge of secondary-treated wastewater and brine waste through the Oceanside Ocean Outfall to the Pacific Ocean. The Oceanside Ocean Outfall is owned and operated by the City of Oceanside.

**Purpose of this Order**

3. This Order makes modifications to Order No. R9-2019-0167 as directed by the California State Water Resources Control Board (State Water Board) on remand pursuant to Order WQ 2021-0005, as well as to update the monitoring and reporting program to be consistent with recently adopted NPDES permits in the San Diego Region and correct non-substantive typographical errors.

**Legal Authorities**

- Order No. R9-2019-0167 is not being reopened for any other purpose than the revisions contained herein. Except as contradicted or superseded by the findings and directives set forth in this Order, all the previous findings and directives of Order No. R9-2019-0167 shall remain in full force and effect.

**California Environmental Quality Act**

- This action is exempt from the requirement of preparation of environmental documents under the California Environmental Quality Act (Public Resources Code, division 13, chapter 3, section 21000 et seq.) in accordance with section 13389 of the Water Code.

**Public Participation**

- The San Diego Water Board has notified all known interested parties of its intent to adopt this Order.
- The San Diego Water Board in a public meeting on December 8, 2021, heard and considered all comments pertaining to the adoption of this Order.
- Any person aggrieved by this action of the San Diego Water Board may petition the State Water Resources Control Board (State Water Board) to review the action in accordance with Water Code section 13320 and California Code of Regulations, title 23, sections 2050 et seq. The State Water Board must receive the petition by 5:00 p.m., 30 days after the adoption date of this Order.
