The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), released Tentative Order No. R9-2021-0197, *An Order Rescinding Order No. R9-2020-0005, Waste Discharge Requirements for Cabrillo Power I LLC, Encina Power Station, San Diego County, Discharge to the Pacific Ocean* (Tentative Order), for public review and comment.
