**TENTATIVE ORDER NO. R9-2023-0008**

**AN ORDER RESCINDING ORDER NO. 95-34,  
WASTE DISCHARGE REQUIREMENTS FOR OUTDOOR WORLD RV PARK, INC.,  
OUTDOOR WORLD RETREAT & RV PARK**

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), finds that:

1. Order No. 95-34, *Waste Discharge Requirements for Outdoor World RV Park, Inc., Outdoor World Retreat & RV Park*, as amended (Order No. 95-34), established requirements for the discharge of domestic wastewater from an onsite wastewater treatment system (OWTS). The Outdoor World Retreat & RV Park OWTS consists of three septic tanks and two leach fields. The Outdoor World Retreat & RV Park OWTS collects wastewater from 151 recreational vehicle (RV) camp sites, three guest cabins, two park models, and a laundry facility. The Outdoor World Retreat & RV Park has an RV dump station that is not currently used. The Outdoor World Retreat & RV Park OWTS is located at 1331 Shasta Way, Boulevard in San Diego County. The San Diego Water Board adopted Order No. 95-34 on August 10, 1995.
2. Order No. 95-34 must be replaced to ensure that the discharge is regulated consistent with current state policy and requirements. Discharges from small OWTS such as these have certain common characteristics, such as similar constituents, concentrations of constituents, disposal techniques, and flow ranges, and they require the same or similar treatment standards. The State Water Resources Control Board issued Order WQ 2014-0153-DWQ, *General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems* (General Order), to regulate these types of discharges consistently throughout the state. Enrollment of the Outdoor World Retreat & RV Park OWTS in the General Order will provide a level of water quality protection equal to that provided in Order No. 95-34.
3. The discharge from the Outdoor World Retreat & RV Park OWTS is less than 100,000 gallons per day and is eligible for enrollment in the General Order based on information submitted in monitoring reports and obtained during a compliance inspection conducted by San Diego Water Board staff on August 23, 2022. As such, the discharge from the Outdoor World Retreat & RV Park OWTS is more appropriately regulated under the General Order than individual waste discharge requirements.
4. MAJOREM, LLC notified the San Diego Water Board on March 4, 2022, that ownership of Outdoor World Retreat & RV Park transferred in 2013. MAJOREM, LLC also notified the Board that the facility name changed from Outdoor World Retreat & RV Park to Boulevard Cleveland Forest KOA. The San Diego Water Board will issue a Notice of Applicability (NOA) to MAJOREM, LLC, for enrollment of the

Boulevard Cleveland Forest KOA OWTS in the General Order prior to the board meeting on March 8, 2023. The NOA's effective date of enrollment in the General Order coincides with the adoption date of this rescission Order.

5. Adoption of Order No. R9-2023-0008 is not subject to the California Environmental Quality Act (CEQA, Public Resources Code, section 21000 et seq.). Pursuant to California Code of Regulations, title 14, sections 15060(c)(2) and 15061(b)(3), the action to rescind Order No. 95-34 will not have potentially significant adverse effects on the environment because the discharges that were regulated by Order No. 95-34 are now regulated under the General Order. In addition, adoption of Order No. R9-2023-0008 is exempt from CEQA pursuant to categorical exemptions listed in title 14, section 15301 (ongoing or existing projects).

The State Water Resources Control Board considered the environmental impacts associated with the adoption of the General Order and prepared an Initial Study in accordance with title 14, section 15063. Analysis in the Initial Study and early consultation with responsible and trustee agencies did not identify any significant impacts on the environment. Therefore, a Negative Declaration was prepared. The State Water Resources Control Board adopted the Negative Declaration on September 23, 2014, through Resolution No. 2014-0054, California Environmental Quality Act, Negative Declaration, General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems. The General Order will provide a level of water quality protection equal to that provided in Order No. 95-34.

6. The San Diego Water Board heard and considered all comments pertaining to the adoption of Order No. R9-2023-0008 in a public meeting on March 8, 2023.

**IT IS HEREBY ORDERED** that Order No. 95-34 is rescinded.
