**SUBJECT**

Consideration of Tentative Order No. R9-2024-0173, *An Order Rescinding Order No. 92-14, Waste Discharge Requirements for Lakeside Land Company, Woodward Sand Pit Reclamation Project, San Diego County* (Tentative Order No. R9-2024-0173). (Amy Grove)

**STAFF RECOMMENDATION**

Staff recommend adoption of Tentative Order No R9-2024-0173 (**Supporting Document 1**).

**KEY ISSUES**

Tentative Order No. R9-2024-0173, if adopted, rescinds Order No. 92-14, *Waste Discharge Requirements for Lakeside Land Company, Woodward Sand Pit Reclamation Project, San Diego County* (Order No. 92-14). Lakeside Land Company (Discharger) ceased all waste discharges to land at the Woodward Sand Pit (Facility) and met the reclamation requirements for the sand and gravel mining operation, as prescribed by the United States Army Corps of Engineers, California Departments of Resources, Recycling, and Recovery, California Department of Fish and Wildlife, and the County of San Diego.

**PRACTICAL VISION**

Tentative Order No. R9-2024-0173 is consistent with the *Strategize for Healthy Waters* chapter of the San Diego Water Board Practical Vision. The rescission of unneeded orders helps the San Diego Water Board focus staff resources on projects and facilities within the region that pose a risk to human health and the environment and a threat to water quality.

**DISCUSSION**

The purpose of this item is to provide the Board with information to assist in its consideration of Tentative Order No. R9-2024-0173. If adopted, Tentative Order No. R9-2024-0173 will rescind Order No. 92-14. The Discharger owns the Facility and is responsible for complying with Order No. 92-14 until rescinded by the adoption of Tentative Order No. R9-2024-0173.

The Facility is located at 10101 Riverside Drive, Lakeside in the County of San Diego (**Supporting Document 2**). The Discharger resubmitted a request to the San Diego Water Board for the rescission of Order No. 92-14 on September 17, 2024. The Discharger's request provided documentation verifying the respective mitigation and reclamation requirements prescribed by the United State Army Corps of Engineers, California Departments of Resources Recycling and Recovery, California Department of fish and Wildlife, and County of San Diego are satisfied. San Diego Water Board staff inspected the Facility on September 23, 2024. During the inspection, Board staff confirmed that the Discharger terminated all waste discharges regulated by Order No. 92-14.

### **PUBLIC NOTICE**

1. Notification of this action was sent to the Discharger and known interested parties on September 26, 2024 (**Supporting Documents 3 and 4**). The San Diego Water Board also posted Tentative Order No. R9-2024-0173 on its website on September 26, 2024, and did not receive any comments. These actions satisfy the 30-day public comment period and 45-day public notification requirements of Water Code, division 7, section 13167.5, and California Code of Regulations title 27, section 21730(b).
