The California Regional Water Quality Control Board, San Diego Region is releasing, for public review and comment, Tentative Order No. R9-2014-0041, An Order Adopting Conditional Waivers of Waste Discharge Requirements for Low Threat Discharges in the San Diego Region (Tentative Order); and Tentative Resolution No. R9-2014-0042 adopting a negative declaration for conditional waivers of waste discharge requirements for low threat discharges in the San Diego Region (Tentative Resolution). The Tentative Order proposes to adopt conditional waivers of waste discharge requirements for low threat discharges in the San Diego Region. The Tentative Order requires the implementation of effective management measures, and structural and non-structural best management practices to address potential impacts associated with storm water run on and runoff, wastes, and wastewaters discharged from qualifying facilities or operations located within the San Diego Region.
