Order R8-2026-0015

Rescission and Party Substitutions of Waste Discharge Requirements and Master
Reclamation Permit
for
Specific Dischargers

The California Regional Water Quality Control Board, Santa Ana Region (hereinafter Santa Ana Water Board), finds that:

1. The Orders listed in Attachment "A" were issued by the Santa Ana Water Board to the dischargers described therein. Attachment "A" is hereby made a part of these Orders. The three Orders for the dischargers listed in Attachment "A" are rescinded or revised as the discharge has ceased or the discharge will be substituted for regulatory coverage by another interested party.
2. This action is based on the fact that the specific discharges have been eliminated, or the project is being transferred to a new entity. As such, this action will not result in a direct or reasonably foreseeable indirect physical change in the environment. Further, there is no possibility that this action may have a significant effect on the environment. Accordingly, this action is exempt from the requirements of the California Environmental Quality Act in accordance with Section 15061(b)(3), Chapter 3, Title 14 of the California Code of Regulations.
3. The Santa Ana Water Board has notified the dischargers, interested agencies and persons of its intent to rescind and revise the orders for the dischargers listed in Attachment "A" and has provided them with an opportunity to submit written comments and recommendations.
4. The Santa Ana Water Board, in a public meeting held on March 13, 2026, heard and considered all comments pertaining to the rescission and revision of waste discharge requirements.

IT IS HEREBY ORDERED that orders previously adopted by the Santa Ana Water Board, shall be rescinded and revised as provided in Attachment "A".
