### **NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD ON THE PROPOSED AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SANTA ANA RIVER BASIN TO EXTEND THE WET WINTER CONDITIONS COMPLIANCE DEADLINE FOR BACTERIAL INDICATOR TOTAL MAXIMUM DAILY LOADS IN THE MIDDLE SANTA ANA RIVER WATERSHED**

**NOTICE IS HEREBY GIVEN THAT** the California Regional Water Quality Control Board, Santa Ana Region (“Santa Ana Water Board”) will hold a public hearing to consider a resolution to approve the draft amendment to the Water Quality Control Plan for the Santa Ana River Basin (Basin Plan) to incorporate a revision limited to extending the schedule for attaining the Middle Santa Ana River Watershed Bacterial Indicator Total Maximum Daily Loads (TMDLs) in Wet Winter Conditions and establishing a Phase 2 Implementation Plan(Basin Plan Amendment).

#### **PUBLIC HEARING**

The Santa Ana Water Board will hold a public hearing to consider adoption of the proposed Basin Plan amendment. The public hearing will be held at the following date, time, and location:

#### **WRITTEN PUBLIC COMMENTS**

The Santa Ana Water Board is seeking written public comments on the draft proposed Basin Plan amendment. **The 30-day comment period will begin on January 27, 2026 and will end at noon on February 26, 2026.**

People interested in the proposed revisions to the Basin Plan amendment and supporting documents are encouraged to submit comments electronically. Comment letters must be received **by 12:00 P.M. on February 26, 2026**. Comment letters received after that deadline will not be accepted unless the Santa Ana Water Board determines otherwise.
