STATE-FILED WATER-RIGHT APPLICATIONS A005633 AND A005634

On July 30, 1927, the State Department of Finance filed water-right Applications A005633 and A005634 under the statute that now is codified as Water Code section 10500. These applications are for water-right permits for direct diversions and seasonal storage of waters of the Bear River. The April 28, 2021 memorandum from Erik Ekdahl, Deputy Director for the State Water Resources Control Board ("State Water Board" or "Board"), Division of Water Rights ("Division"), to Eileen Sobeck, the State Water Board's Executive Director, a copy of which is in Attachment 1, describes these State-filed applications in more detail.

PETITION FOR PARTIAL ASSIGNMENT OF APPLICATION A005634 AND PROPOSED WATER-RIGHT APPLICATION A005634X01

On August 13, 2014, Nevada Irrigation District ("Nevada ID") filed, under Water Code section 10504.01: (1) a petition for partial assignment of State-filed Application A005634; and (2) proposed water-right Application A005634X01. The April 28, 2021 memorandum from Mr. Ekdahl describes this petition and this proposed application in more detail.

The Division of Water Rights issued a public notice of this petition and proposed application on August 26, 2016. The following parties filed protests: The United

Auburn Indian Community of the Auburn Rancheria, South Sutter Irrigation District, United States Department of Interior, Bureau of Reclamation, American River Watershed Institute, County of Placer, Placer County Water Agency, California Department of Fish and Wildlife, Pacific Gas and Electric Company, Foothills Water Network, Contra Costa Water District, Pacific Forest and Watershed Lands Stewardship Council, Richard and Stephanie Currin, David and Cheryl Sprunck, Diana and Cam Suarez, Celia Hulett, Joan Hoss, and Kristen Mitchell. The Division's files do not indicate that any of these protests have been resolved.

REQUESTS FOR RELEASES FROM PRIORITY

On November 9, 2016, South Sutter Water District ("South Sutter WD") filed requests under Water Code section 10504 for releases from the priorities of Applications A005633 and A005634 in favor of South Sutter WD's water-right License 11120 (Application 10221). License 11120 has a priority date of June 13, 1941. The April 28, 2021 memorandum from Mr. Ekdahl describes South Sutter WD's requests and License 11120 in more detail.

On February 21, 2021, South Sutter WD sent a letter to the Division, which asked for action on its requests for releases from priority and stated that South Sutter WD believed that Nevada ID had abandoned its efforts to petition for assignment of State-filed Application A005634.

ASSIGNMENT TO THE ADMINISTRATIVE HEARINGS OFFICE

Water Code section 1110 established the AHO as an independent organizational unit within the State Water Board. Water Code section 1112, subdivision (c)(2), provides that the Board may assign an adjudicative hearing to the AHO. Water Code section 1114 provides that, after the AHO holds a hearing in an assigned matter, the AHO hearing officer shall prepare a proposed order and transmit it to the Board for the Board's consideration.

Mr. Ekdahl's April 28, 2021 a memorandum to Ms. Sobeck recommended that the Executive Director assign these applications, this petition and proposed application and these requests for releases from priority to the AHO to consider and resolve various issues, which are listed in the memorandum.

On May 18, 2021, Ms. Sobeck transmitted a memorandum to Alan Lilly, Presiding Hearing Officer AHO, which assigned Nevada ID's petition for assignment of State-filed Application A0056334, Nevada ID's proposed Application A005634X01, and Sutter S30531B to the AHO (Attachment 2).

HEARING OFFICER AND HEARING TEAM: NOTICE OF STATUS CONFERENCE

A hearing officer from the State Water Board's Administrative Hearings Office will preside over any status conference or hearing in this matter. Other members of the

AHO may be present and assist the hearing officer throughout these proceedings.

The AHO will be issuing a notice of status conference for this matter.

PROHIBITION ON EX PARTE COMMUNICATIONS

Parties and interested persons are prohibited from having any ex parte communicationswith any members of the AHO hearing team. (See Wat. Code, § 1110, subd. (c); Gov. Code, §§ 11430.10-11430.80.) A party or interested person may provide the proof of service through a formal proof of service or by other verification. For letters, the verification shall be a list of the names and mailing addresses of the other parties or their representatives in the cc portion of the letter. Until the AHO issues an updated service list, parties should use the initial service list attached to this notice (Attachment 3).

Please do not attempt to communicate by telephone or in person with AHO staff or any AHO hearing team member regarding these proceedings, because other parties would not be able to participate in such communications. If oral communications with members of the AHO hearing team are necessary to discuss a procedural or substantive issue, the AHO will set up a conference call in which representatives of all parties may participate. Any party may request such a conference call at any time using the written communications protocols described above.

Water Rights files for Applications A005633, A005634 and A005634X01, and current information available to the AHO. The State Water Resources Control Board (State Water Board or Board) Division of Water Rights (Division) proposes assignment of the pending petition for partial assignment of state-filed Application A005634 and accompanying Application A005634X01 filed by Nevada Irrigation District (NID) and the related petitions for release from priority of state-filed Applications A005633 and A005634 filed by South Sutter Water District (SSWD) to the Administrative Hearings Office (AHO) for further proceedings and an adjudicative hearing.

Background

State Filed Application A005634

State-filed Application A005634 has a calculated face value of 399,591 acre-feet per year. The following is a summary of the state-filed application (as filed). Application A005634 has not been assigned in part to any other party and there are no other pending petitions for assignment other than the petition filed by NID. The Division noticed the NID petition and accompanying application on August 26, 2016. Protests were received and are pending. The following description of the petition and Application A005634X01 was included in the public notice.

Petitions for Release from Priority of A005633 and A005634

SSWD filed a protest and remains an active protestant to the NID petition for assignment of Application A005634 and accompanying Application A005634X01.

On November 9, 2016, SSWD filed petitions for release from priority of state-filed Applications A005633 and A005634 in favor of SSWD's water-right License 11120 (Application 10221). Applications A005633 and A005634 have a priority date of July 30, 1927. License 11120 has a priority date of June 13, 1941. SSWD seeks a release of priority in favor of License 11120 for the storage of 40,000 acre-feet per year at Camp Far West Reservoir on the Bear River in Yuba and Placer Counties. The effect of the requested release from priority is that any water-right resulting from the assignment of Applications A005633 and A005634 would have a lower priority than up to 40,000 acrefeet per year of water diverted to storage under License 11120.

On February 25, 2021, SSWD submitted a letter to the Division requesting action on its petitions for release from priority and an update on the status of the petitions. In that letter, SSWD indicated its view that NID had abandoned its effort to petition for assignment of A005634.

Summary of State-Filed Application 5633

The following is a summary of state-filed Application A005633. The calculated face value of A005633 is 196,877 acre-feet per year. The application has not been assigned in part to any other party and there are no pending petitions seeking assignment of the filing. Application A005633 is not part of NID's petition for assignment. The point of diversion and location of storage of A005633 is at the same reservoir as A005634 but is for the purpose of use of power generation.

Issues to be Considered by the Administrative Hearings Office

While staff have engaged extensively on NID's petition in the past, current low levels of permitting staffing have not provided sufficient resources to focus on this project over the last several years.

Given the size and complexity of this project and high level of public interest, this matter would be aided by the AHO's expertise in conducting adjudicative hearings and ensuring water rights disputes are resolved in a timely manner. Therefore, the Division proposes that the AHO address the following issues and draft a proposed order for the Board, the Executive Director, or the Deputy Director for Water Rights, for consideration:

- 1) Whether NID seeks to continue to pursue the petition for assignment of statefiled Application A005634 and Application A005634X01.
- 2) The status of the NID petition and accompanying Application A005634X01, including but not limited to the status of completion and submission of a:
 - a. Water availability analysis,
 - b. Required environmental documentation, and
 - c. Resolution of pending protests.
- 3) Whether the Board should approve the NID petition for assignment of state-filed Application A005634 and whether the Board should approve Application A005634X01, in whole or in part, and if so, with what terms and conditions.
- 4) Should the Board continue to process the petitions for release from priority filed by SSWD if NID withdraws its petition (and accompanying application) for assignment of state-filed Application A005634 or its petition (and accompanying application) is cancelled or rejected by the Board.

If NID's petition and accompanying application or the SSWD petitions for release from priority remain pending after adoption of any proposed order resulting from the AHO's proceeding(s), the Division will continue processing the petitions for release from priority and the petition for assignment (and accompanying application) in accordance with all applicable rules and regulations related to permitting and state-filed applications. Alternatively, the AHO may manage the process in coordination with the Division.

Conclusion and Recommendation

Given the complexity and controversial nature of the petition for assignment and accompanying application and petitions for release from priority, resolution of these issues would be most effectively achieved through a proceeding conducted by the AHO. Therefore, I am recommending assignment of this matter to the AHO for noticing and further proceedings and an adjudicative hearing to address the issues identified in this memo.
