On February 18, 2022, we understand the Division of Water Rights issued an Administrative Civil Liability (ACL) Complaint to Smith Frances E. Trust, alleging that the Trust violated online curtailment certification requirements under California Code of Regulations, title 23, section 879, by failing to file a required certification by the applicable deadline. A representative of Smith Frances E. Trust requested a hearing on March 8, 2022.

On March 19, 2022, the Smith Trust representative sent an e-mail to the AHO withdrawing the request for a hearing. The AHO did not set a hearing date for this matter.

Based on Smith Trust's withdrawal of the hearing request, the AHO will not schedule a hearing and is closing its file in this matter.
