### **NOTICE OF CANCELATION OF HEARING**

The State Water Resources Control Board  
Administrative Hearings Office  
is Canceling the Public Hearing  
on a proposed Cease and Desist Order  
and an Administrative Civil Liability Complaint  
against

**Maria and Bruno Lenta**

that was to be held on **July 13, 2023**.

#### **TO ALL PARTIES:**

On December 1, 2022, Julé Rizzardo, Assistant Deputy Director for the State Water Resources Control Board (State Water Board or Board) Division of Water Rights (Division) Enforcement Section, issued an administrative civil liability complaint (ACL Complaint) and draft cease and desist order (Draft CDO) to the Respondents Maria and Bruno Lenta. The letter transmitting the ACL Complaint and Draft CDO notified the Respondents of the right to request a hearing to contest the allegations in the Draft CDO and ACL Complaint. On January 12, 2023, the Respondents requested a hearing on the Draft CDO and ACL Complaint.

The State Water Resources Control Board's Administrative Hearings Office (AHO) issued a Notice of Public Hearing on May 26, 2023. This Notice of Public Hearing set a hearing date of July 13, 2023, beginning at 9:00 a.m.

On July 5, 2023, Heather Jidkov, an attorney with the Board's Office of Enforcement, advised the AHO that the Division's Prosecution Team and the Respondents had reached a settlement agreement that addressed the alleged violations in the Draft CDO and ACL Complaint, and requested that the AHO cancel the hearing scheduled in this matter.

Based on the settlement agreement between the Respondents and the Division's Prosecution Team, the AHO cancels the hearing in this matter that was scheduled for July 13, 2023, beginning at 9:00 a.m, and is closing its file in this matter.
