SUMMARY OF THIRD AMENDED NOTICE OF PUBLIC HEARING REGARDING THE DELTA CONVEYANCE PROJECT

PURPOSE OF PUBLIC HEARING

The State Water Resources Control Board (State Water Board or Board) Administrative Hearings Office is holding a public hearing about the Delta Conveyance Project that will **continue on March 24 and 25, 2025** and to additional dates in April and beyond.

The hearing will address the water right change petitions filed by the Department of Water Resources to add two new points of diversion and rediversion to the water rights associated with the State Water Project, Permits 16478, 16479, 16481, and 16482 (Applications 5630, 14443, 14445A, and 17512, respectively). The proposed new points of diversion and rediversion would consist of screened intakes 2.3 miles apart located on the lower Sacramento River between Freeport and Sutter Slough. These intakes would allow the Department of Water Resources to divert water from the Sacramento River in the northern portion of the Sacramento-San Joaquin Delta Estuary (Delta) and convey the water through a tunnel to existing water distribution facilities in the southern Delta.

The purpose of the hearing is to gather evidence to determine whether to approve these petitions and, if so, what specific terms and conditions, if any, should be included in the amended permits for the State Water Project.
