NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public hearing to seek comments on the proposed Water Quality Control Plan (Plan) for Enclosed Bays and Estuaries of California, Sediment Quality Objectives. The State Water Board will not take any action at the hearing. Action by the State Water Board will be at a subsequent noticed meeting.

BACKGROUND

In 2003, the State Water Board initiated a program to protect enclosed bays and estuaries through the development of sediment quality objectives (SQOs). The SQOs use a multiple line of evidence that integrates the chemistry, toxicity, and condition of the benthic community to determine the health of the sediment.

SUBMISSION OF COMMENTS


