Footnotes:

1) The CWSRF and WRFP project funding values are updated based on actual construction contract values through a funding agreement amendment process.

2) The Interest Rate of the "Estimated Standard Rate Loan" for CWSRF loan funds is set at one-half of the most recent State GO Bond Rate.

3) "Estimated WRFP construction grant" value indicates the total funding commitment based on engineering estimates.

4) San Benito CWD and Pajaro Valley WMA opted to receive WRFP grant funds only and did not receive loan funds. Idyllwild Water District and Delta Diablo had an executed Agreement but have since cancelled their projects.

Padre Dam MWD made substantial changes to the originally submitted project application, making the project ineligible for 1% financing. The project is set to receive standard rate loan instead.
