NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT ON PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SAN DIEGO BASIN (BASIN PLAN) TO INCORPORATE REVISED CONDITIONAL WAIVERS OF WASTE DISCHARGE REQUIREMENTS FOR SPECIFIC TYPES OF DISCHARGE WITHIN THE SAN DIEGO REGION

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of an amendment to the Basin Plan that would incorporate revised conditional waivers of waste discharge requirements for specific types of discharge within the San Diego Region. The amendment, adopted by the San Diego Regional Water Quality Control Board (San Diego Water Board), the State Water Board agenda language, and draft resolution are available on the State Water Board's Web site at http://www.waterboards.ca.gov/water_issues/programs/tmdl/tmdl.shtml#rb9 or can be received by mail by contacting Nirmal Sandhar at (916) 341-5571. The amendment was adopted by the San Diego Water Board on October 10, 2007, under [Resolution No. R9-2007-0104](#). The State Water Board expects to consider approval of the amendment in the future. Notice of that meeting will be published separately.

Comment letters to the State Water Board **must be received by 12:00 noon on September 22, 2008**. After the September 22, 2008 deadline, State Water Board staff will not accept additional written comments unless the State Water Board determines that such comments should be accepted.
