NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT

ON UNDERGROUND STORAGE TANK CASE CLOSURE FOR BEACON STATION #3556 ULTRAMAR, INC. (PETITIONER) 900 MORRO BAY BOULEVARD, MORRO BAY, CALIFORNIA

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed underground storage tank (UST) case closure for Central Coast Regional Water Quality Control Board UST case number 2371, Beacon Station #3556, 900 Morro Bay Boulevard, Morro Bay, California.

Enclosed is a draft UST case closure summary prepared by State Water Board staff for the above-entitled matter. Pursuant to Health and Safety Code Section 25296.40, the State Water Board will be considering, at a future board meeting, whether this UST case should be closed. You will separately receive an agenda for this meeting.

All comments shall be based solely upon evidence contained in the record or upon legal argument. Supplemental evidence will not be permitted except under the limited circumstances described in California Code of Regulations, Title 23, Section 2814.8.

SUBMISSION OF WRITTEN COMMENTS

Interested persons and parties are encouraged to submit their comments in writing. Comment letters to the State Water Board **must be received by 12:00 noon on Friday, September 2, 2011.** After the deadline, staff will not accept additional written comments unless the State Water Board determines that such comments should be accepted.
