The Orange County Health Care Agency (OCHCA) has reviewed the case closure review summary report prepared by the State Water Resources Control Board (SWRCB) staff regarding case closure recommendation made by the UST Cleanup Fund Manager for the referenced site.

This Agency has reviewed the site history and evaluated the case for closure. A Case Closure Summary prepared by this Agency has been forwarded to the California Regional Water Quality Control Board – San Ana Region (RWQCB) on March 21, 2013 for their review and concurrence. (See attached e-mail correspondence sent to RWQCB.) Pursuant to Sections 25297.1 and 25297.15 of the California Health and Safety Code, draft Case Closure Summary has also been submitted to all interested parties and water agencies on March 21, 2013 as part of the public notification process. As such, the OCHCA requests that the SWRCB dismiss the Fund Manager's recommendation for closure as it would be premature to close the case at this time, as the closure process is already underway by the local agency.
