Petition for Change: Add Poundstone Plant within SW¼ of SW¼ of section 26, T13N, R1E, MDB&M.

**Description of Proposed Change**

The petitioner proposes to add a point of diversion along the Sacramento River to use a new screened pumping facility (Poundstone Pumping Plant) that will affect three of the District's existing water rights Licenses 3065, 3066, and 3067 and pending Application 31436. The petitioner's intent is to consolidate at a new screened pumping plant (Poundstone Pumping Plant) located approximately 4,000 feet south of Boyer's Landing. The petitioner wants to keep the existing points of diversion in case of emergency.
