Petition for Change

Petition for Extension of Time

Before the State Water Resources Control Board (SWRCB) can approve a petition to change your water right permit or a petition for extension of time to complete use, the SWRCB must consider the information contained in an environmental document prepared in compliance with the California Environmental Quality Act (CEQA). This form is not a CEQA document. If a CEQA document has not yet been prepared, a determination must be made of who is responsible for its preparation. As the petitioner, you are responsible for all costs associated with the environmental evaluation and preparation of the required CEQA documents. Please answer the following questions to the best of your ability and submit any studies that have been conducted regarding the environmental evaluation of your project. THIS RIGHT IS PART OF THE AGGREGATE AMOUNT OF WATER DIVERTED FROM SNOW CREEK (TWIN SPRINGS CREEK) AND JUNE LAKE THAT SERVES THE VILLAGE SYSTEM SERVICE AREA. THE TOTAL AMOUNT OF WATER THAT CAN BE DIVERTED UNDER APPLICATIONS 27220, 16687, 27239, 28123, AND 28124 SHALL NOT EXCEED 0.74 CFS FOR A TOTAL OF 536 ACRE-FEET PER YEAR. WATER DIVERTED FROM SNOW CREEK IS TREATED FOR USE AT THE SNOW CREEK WATER TREATMENT PLANT, AND WATER DIVERTED FROM JUNE LAKE IS TREATED AT THE JUNE LAKE WATER TREATMENT PLANT. PER THE DISTRICT'S MASTER WATER PLAN JULY 2004, THE DISTRICT PROVIDES WATER TO APPROXIMATELY 77 DEVELOPED ACRES WITH 138 ACRES YET TO BE DEVELOPED. OF THE 138 ACRES YET TO BE DEVELOPED APPROXIMATELY 20 ACRES ARE APPROVED FOR TWO SUBDIVISIONS OF SINGLE-FAMILY RESIDENCES WITH INFRASTRUCTURE UNDER CONSTRUCTION AND ANOTHER 90 ACRES IS IN THE PLANNING STAGE WITH DEVELOPMENT SCHEDULED WITHIN THE NEXT 5-10 YEARS. THESE WATER SOURCES HAVE BEEN CONSTRUCTED BUT ADDITIONAL TIME IS NEEDED TO FULLY MAXIMIZE THE DIVERSIONS UNDER THIS
