Petition for Extension of Time

Before the State Water Resources Control Board (SWRCB) can approve a petition to change your water right permit or a petition for extension of time to complete use, the SWRCB must consider the information contained in an environmental document prepared in compliance with the California Environmental Quality Act (CEQA). This petition for change modifies the existing Permit 17421 to reflect actual "on the ground" conditions. The changes proposed under this petition for change include the addition of two new points of diversion: The "Riverside Well Field" (containing wells #1-#4), and Well #5 located on the Brian R. White property. The Riverside Well Field (Wells #1-#4) and Well #5 are existing, cased wells that draw underflow from the Russian River. No new construction activities, or ground disturbing activities are proposed as a part of this project. These five wells replaced the previous water collection facility, described in the original application (raney collector) and have been in use since the 1960's and 1970's. 
