Attachment #3
Project Description

Petitioner proposes to increase the authorized place of use to include additional existing and proposed vineyard, as shown on the attached map and to add irrigation as an authorized purpose of use under this permit. The place of use will be increased from 382 acres to 703 acres. The amount of water to be used on the requested place of use (703 acres) will not exceed the 600 acre-feet of direct diversion and 50 acre-feet of diversion to storage authorized pursuant to this permit. These lands will also be named in the Place of Use for Applications 17624, 24139 and 29763. The majority of the requested place of use is developed. The proposed place of use will be located in cleared areas and no trees are proposed to be removed pursuant to this Petition. The proposed place of use and associated water service and transmission systems will need to be developed pursuant to this petition.

The petitioner also seeks to redistribute storage, (as shown above) from the existing offstream McNab reservoir to proposed offstream reservoir "C". The McNab reservoir already stores 50 acre-feet under License 12649. Offstream Reservoir "C" is proposed to be a pit type reservoir and will have a capacity of 50 acre-feet.

Finally, the Petitioner requests an extension of time to complete planting of the proposed place of use, construct Offstream Reservoir "C" and make full beneficial use of the water authorized pursuant to this Permit.
