Petition for Extension of Time

Before the State Water Resources Control Board (SWRCB) can approve a petition to change your water right permit or a petition for extension of time to complete use, the SWRCB must consider the information contained in an environmental document prepared in compliance with the California Environmental Quality Act (CEQA). This form is not a CEQA document. If a CEQA document has not yet been prepared, a determination must be made of who is responsible for its preparation. As the petitioner, you are responsible for all costs associated with the environmental evaluation and preparation of the required CEQA documents. The Trinity Village Water Company (water permit #17650 application # 24462) serves the Trinity Village service area. The subdivision service area is located in rural Trinity County and has approx. 250 lots. To date approximately 189 lots have been developed / constructed on. The area is categorized as depressed and subject to seasonal economic constraints. Thus, it has taken a long time to reach build out of this service area. The Trinity Village Water Company's treatment plant, storage facilities, distribution system and metering to all lots was completed in 1965. Nothing remains to be done except putting water to full beneficial use. We expect full build out by 2016. The Trinity Village Subdivision started as a summer home community but was


