## AMENDED NOTICE OF PETITION REQUESTING MODIFICATION TO WATER RIGHT PERMITS FOR SONOMA COUNTY WATER AGENCY BY MODIFYING THE MINIMUM INSTREAM FLOW REQUIREMENTS

PERMITS 12947A, 12949, 12950, AND 16596  
(APPLICATIONS 12919A, 15736, 15737 AND 19351)

**DATE PETITION FILED:** September 23, 2009

**COUNTY:** Mendocino and Sonoma

**STREAM SYSTEM:** Russian River

The State Water Resources Control Board (State Water Board) hereby issues an Amended Notice of a petition requesting modification to water right permits for the Sonoma County Water Agency (SCWA). This Amended Notice is being issued to allow for additional time for public review of the subject petition. **If protests have already been filed with the State Water Board they do not need to be resubmitted during the extended review period.**

The SCWA has petitioned the State Water Board to amend water right Permits 12947A, 12949, 12950 and 16596 (Applications 12919A, 15736, 15737 and 19351) by modifying the minimum instream flow requirements of the Russian River below Lake Mendocino and Lake Sonoma. The State Water Board will consider the Petitioner's request and determine whether the water right permits will be amended and, if so, whether additional conditions should be included in the amended permits to protect the environment and downstream water users. ### Project Description

The State Water Board adopted Water Right Decision 1610 (D-1610) in 1986 amending the SCWA's permits and setting the current minimum instream flow requirements for the Russian River. The SCWA has requested changes to the minimum instream flow requirements of their permits in order to implement the reasonable and prudent alternative (RPA) specified by the National Marine Fisheries Service (NMFS) in its *Biological Opinion for Water Supply, Flood*

**California Environmental Protection Agency**

*Control Operations, and Channel Maintenance conducted by the U.S. Army Corps of Engineers, the Sonoma County Water Agency, and the Mendocino County Russian River Flood Control and Water Conservation Improvement District in the Russian River Watershed* (Biological Opinion), issued on September 24, 2008. In its Biological Opinion, NMFS concluded that the current minimum instream flow requirements have an adverse effect on Central California Coast Steelhead (*Oncorhynchus mykiss*) and Central California Coast Coho Salmon (*Oncorhynchus kisutch*) because the artificially high flows limit the quality and quantity of rearing habitat. Based on the findings in the Biological Opinion, SCWA has petitioned to modify the minimum instream flow requirements in an attempt to avoid further jeopardizing steelhead trout and coho salmon populations. The proposed modifications are intended to augment usable rearing habitat, improve salmonid population growth, and improve spatial structure of the populations. For further information on the proposed modifications to the minimum instream flow requirements please see the attached Petition and Exhibit 1 provided by the SCWA.

### **Petition Information**

SCWA's petitions involve the following permits:

- Permit 12947A is for direct diversion of 92 cubic feet per second (cfs) for the East Fork Russian River and storage of 122,500 acre-feet per annum (afa) in Lake Mendocino from January 1 through December 31 of each year. The purposes of use are domestic, irrigation, municipal, industrial, and recreation.
- Permit 12949 is for 20 cfs to be directly diverted year-round from the Russian River at the Wohler and Mirabel Park Intakes near Forestville. The purposes of use are domestic, municipal, and industrial.
- Permit 12950 is for 60 cfs to be directly diverted from the Russian River at the Wohler and Mirabel Park Intakes near Forestville from April 1 through September 30 of each year. The purposes of use are domestic, irrigation, and municipal.
- Permit 16596 is for (1) year-round direct diversion of 180 cfs from the Russian River and (2) storage of 245,000 afa in Lake Sonoma from October 1 of each year to May 1 of the succeeding year. The purposes of use are domestic, municipal, industrial, and recreation.

The place of use for the above permits is the service area for SCWA, and for Permit 12947A the place of use also includes Lake Mendocino and the Redwood Valley County Water District.

The proposed modifications to the minimum instream flows involve modifications to the following terms in each of the permits:

- Term 20 on pages 5-6 of Amended Permit 12947A
- Term 17 on pages 4-5 of Amended Permit 12949
- Term 17 on pages 4-5 of Amended Permit 12950
- Term 13 on pages 4-5 of Amended Permit 16596

The specific modifications to each permit term can be found in SCWA's Exhibit 1, attached to

this notice.

### Environmental Information

SCWA is the Lead Agency as defined in the California Environmental Quality Act (CEQA) for this petition. The State Water Board will be a Responsible Agency as defined by CEQA. The SCWA will prepare the CEQA document for this petition, and provide all notices and submissions to the State Water Board as required by CEQA.
