NOTICE OF PETITIONS FOR CHANGE FOR LICENSES 174, 659, AND 660 (APPLICATIONS 84, 553, AND 554)

County: Riverside

Stream System: Millard Canyon

Morongo Band of Mission Indians (“Petitioner”) filed petitions for change, seeking to change the places and purposes of use, and method of diversion of the above referenced licensed water rights on January 24, 2006. The State Water Resources Control Board (State Water Board) had previously initiated a hearing on the Notice of Proposed Revocation regarding License 659 to determine whether cause exists to revoke the license. Final action on the petition on License 659 will be deferred until the State Water Board makes a determination whether License 659 should be revoked.
