The County Sanitation Districts of Los Angeles County ("Districts") seek a wastewater change petition to supply additional water from its Long Beach Water Reclamation Plant ("LBWRP") to the Water Replenishment District of Southern California ("WRD") for additional treatment at WRD's Leo Vander Lans Water Treatment Facility ("LVLWTF") before its ultimate use at the Alamitos Gap Seawater Intrusion Barrier. The treated wastewater is currently discharged by the Districts from the LBWRP to Coyote Creek.

LBWRP generates approximately 18 MGD of highly treated effluent, of which 12 MGD is discharged to Coyote Creek under NPDES permit and 6 MGD is recycled (see Attachment 1). Approximately 3.5 MGD of the 6 MGD of recycled water is delivered to WRD's LVLWTF to produce 3 MGD of advanced treated water for the Alamitos Seawater Intrusion Barrier, and approximately 2.5 MGD of recycled water is used by the city of Long Beach for landscape irrigation. WRD is expanding capacity of the LVLWTF to increase supply of recycled water to the Barrier by an additional 5 MGD that will reduce an equal quantity of potable water that is currently being used. The Districts propose to reduce LBWRP discharges to Coyote Creek accordingly to meet this demand. This substitution of recycled water for a portion of the water used for the seawater intrusion barrier will effectively extend the available potable water supplies for Southern California by 5 MGD.

The source water for the LBWRP is predominately foreign water to Coyote Creek and the entirety of the requested change can be accomplished using foreign water (see Attachment 1 to Petition for Change). Because the existing infrastructure currently delivers recycled water from LBWRP to LVLWTF, this wastewater change petition will involve no new construction or excavation activity, or changes in land use by the Districts. The expanded LVLWTF (mechanical equipment, etc.) will be constructed by the WRD on previously graded and disturbed land. There will also be minimal impacts to biological resources, as explained in Attachment 2.
