**NOTICE OF WASTEWATER CHANGE PETITION WW0091 AND  
PETITION FOR CHANGE IN PLACE OF USE FOR  
ORDER APPROVING WASTEWATER CHANGE PETITION WW0019**

COUNTY: Los Angeles

STREAM SYSTEM: Los Angeles River

The City of Burbank (City) has filed two petitions with the State Water Resources Control Board regarding treated wastewater from the City's Waste Water Treatment Plant, which discharges during all months of the year to the Burbank Western Channel two miles from the confluence of the Los Angeles River. The first petition (WW0091) seeks to change the purpose of use and place of use of a portion of the treated wastewater being discharged to the channel. The second petition (WW0019) seeks to change the place of use for treated wastewater authorized for irrigation and industrial use by the State Water Resources Control Board's March 4, 1993 Order approving Wastewater Change Petition WW0019. The proposed changes will be reviewed by the State Water Resources Control Board pursuant to the provisions of Chapter 10 of Part 2 of Division 2 of the Water Code.
