**NOTICE OF PETITIONS FOR CHANGE
FOR LICENSES 9450 AND 9541 (APPLICATIONS 20134 AND 22523) OF
ALLIANCE REDWOODS CONFERENCE GROUNDS**

COUNTY: SONOMA

STREAM SYSTEM: Russian River

On March 6, 2018, Alliance Redwoods Conference Grounds (ARCG) filed petitions to change water right Licenses 9450 and 9541 (Applications 20134 and 22523, respectively) with the State Water Resources Control Board, Division of Water Rights. As part of a fisheries enhancement project to improve flows in Dutch Bill Creek, ARCG is seeking to move the points of diversion of Licenses 9450 and 9541 from their current locations on a tributary to Dutch Bill Creek, downstream to a point at the confluence of Dutch Bill Creek and the Russian River.
