Notice is hereby given a petition has been filed with the State Water Resources Control Board (State Water Board), Division of Water Rights pursuant to Water Code section 1707. The petition for change for Adjudicated Water Right J000028 was filed by Matthew Clifford of Trout Unlimited, acting as agent for Peninsula Open Space Trust. The petition requests changes to the adjudicated place of use and purpose of use to allow for the permissive dedication of water reported under Statement of Diversion and Use S001220 for fish and wildlife preservation and enhancement in San Gregorio Creek. The point of diversion in the subject petition and statement of diversion and use is referenced as Diversion No. 225 in Decree No. 355792 issued by the San Mateo County Superior Court in January 1993.

### Summary of J000028 (Diversion Number 225) and Changes Requested by Petition

Source: San Gregorio Creek tributary to the Pacific Ocean

Season of Diversion: April 1 to November 1 of each year

Amount: 240,600 gallons per day by direct diversion

**Point of Diversion:** located at North 1,947,707 feet, East 6,015,368 feet by California Coordinate System, Zone 3, North American Datum 83

#### Purposes of Use:

<u>Existing:</u> irrigation <u>Requested by Petition:</u> the addition of fish and wildlife preservation and enhancement

#### Place of Use:

<u>Existing:</u> 4 acres within Section 10, and 60.5 acres within Section 15, all within Township 7 South, Range 5 West, Mount Diablo Base and Meridian <u>Requested by Petition:</u> the addition of approximately 2.8 river miles of instream place of use extending from the point of diversion on San Gregorio Creek to the Pacific Ocean
