NOTICE OF PETITIONS FOR CHANGE AND TIME EXTENSION FOR WATER RIGHT PERMIT 21198 (APPLICATION 31055) OF CAMP MEEKER RECREATION AND PARK DISTRICT

COUNTY: Sonoma

STREAM SYSTEM: Russian River

On May 18, 2018, and October 9, 2020, Camp Meeker Recreation and Park District (Camp Meeker) filed petitions for change for instream flow dedication and extension of time for water right Permit 21198 (Application 31055) with the State Water Resources Control Board, Division of Water Rights (Division). A summary of Permit 21198 and the changes requested with the petitions follows.

Summary of Permit 21198 and Proposed Changes:

<u>Source:</u> Russian River Underflow tributary to the Pacific Ocean

Point of Diversion: Monte Rio offset well within NW¼ of SE¼ of Section 7, T7N, R10W, MDB&M

<u>Season of Diversion:</u> January 1 to December 31 of each year

<u>Amount of Water:</u> 0.23 cubic foot per second by direct diversion not to exceed 90 acre-feet per annum

<u>Purposes of Use:</u> **Existing:** Municipal and Fire Protection

Additional Purpose of Use Requested with Petition: Addition of Fish and Wildlife Preservation and Enhancement

Places of Use:

Existing: Within the boundaries of Camp Meeker as shown on map filed with the State Water Board, being within portions of Sections 21, 22, 27, and 28, T7N, R10W, MDB&M

Additional Place of Use Requested with Petition: Addition of a reach of Dutch Bill Creek to the place of use for Fish and Wildlife Preservation and Enhancement. The upstream limit is located at North 1,921,868 feet and East 6,282,809 feet by CCS83, Zone 2, being within NE¹/₄ of SW¹/₄ of Section 21, T7N, R10W, MDB&M. The

downstream limit is located at the confluence of Dutch Bill Creek and the Russian River at North 1,932,731 feet and East 6,272,591 feet by CCS83, Zone 2, being within NE¹/₄ of SW¹/₄ of Section 7, T7N, R10W, MDB&M

Time to Complete Beneficial Use: *Existing:* December 31, 2017

Extension Requested with Petition: December 31, 2027
