NOTICE OF PETITION FOR TIME EXTENSION FOR WATER RIGHT PERMIT 21237 (APPLICATION 5648G) OF LAKE ALPINE WATER COMPANY AND COUNTY OF ALPINE

COUNTY: Alpine STREAM SYSTEM: Bear Creek tributary to Stanislaus River System

On October 7, 2020, Lake Alpine Water Company and the County of Alpine (Alpine) filed a petition for extension of time for water right Permit 21237 (Application 5648G) with the State Water Resources Control Board, Division of Water Rights (Division). A summary of Permit 21237 and the change requested with the petition follows.

Summary of Permit 21237 and Proposed Change:

Source:

Bear Creek tributary to Bloods Creek thence North Fork Stanislaus River thence Stanislaus River

Point of Diversion:

Reba Dam (Bear Lake), located within the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 7, T7N, R18E, MDB&M

Season of Diversion:

October 1 of each year through July 31 of the succeeding year

Amount of Water:

Direct diversion of up to 0.78 cubic foot per second, not to exceed 175 acre-feet annually (afa), and storage of up to 220 afa. The maximum amount of water to be taken from the source shall not exceed 395 afa.

Purposes of Use:

Municipal and Recreation

Place of Use:

Within the service area of Lake Alpine Water Company, within T7N, and R17E through R18E, MDB&M, as described and delineated on the Alpine's map on file with the Division.

Time to Complete Beneficial Use:

Existing: December 31, 2020

Extension Requested with Petition: December 31, 2070

Pursuant to California Water Code section 1703.1, any interested person may file a protest to the proposed change. Protests filed in response to this notice should be submitted to the persons listed below and must be received by the Division by 4:30 p.m. on **September 27, 2021**. Protests may be provided via email prior to the deadline; however, a copy of the original signed letter of protest must be subsequently filed with the Division.
