NOTICE OF PETITION FOR CHANGE WATER RIGHT LICENSE 3906 (APPLICATION 12572) OF CITY OF LODI

COUNTY: San Joaquin **STREAM SYSTEM:** Dredger Cut tributary to San Joaquin River

On June 25, 2021, the City of Lodi (Lodi) filed a petition to change water right License 3906 (Application 12572) with the State Water Resources Control Board, Division of Water Rights (Division). A summary of License 3906 and the changes requested with the petition follow.

Proposed with petition:

Lodi stated that POD 1 has been abandoned and requested that POD 1 be deleted from License 3906.

January 1 to December 31 of each year

Amount of Water:

Direct diversion of 5.84 cubic feet per second

Purposes of Use:

Irrigation and Stockwatering

Places of Use:

Current:

A total of 460 acres as follows: 1) 145.6 acres within Section 26, T3N, R5E, MDB&M; and 2) 314.4 acres within Section 25, T3N, R5E, MDB&M.

Proposed with petition:

A net of 819 acres within a gross of 831 acres as follows: 1) 207 acres within Section 23, T3N, R5E, MDB&M; 2) 112 acres within Section 24, T3N, R5E, MDB&M; 3) 413 acres within Sections 25 and 26, T3N, R5E, MDB&M; and 4) 99 acres within
