## NOTICE OF PETITION FOR TEMPORARY URGENCY CHANGE FOR PERMIT 21112 (APPLICATION 5645B)

COUNTIES:

EFFECTIVE DATE: 180 days from issuance of order on petition.

The petition requests authorization to temporarily store 4,000 acre-feet (af) of water released from Caples Lake in Jenkinson Lake by (1) adding Jenkinson Lake as a temporary place of storage; (2) adding a point of rediversion at Sly Park Dam (which forms Jenkinson Lake); (3) adding a point of rediversion at El Dorado Canal to convey water from South Fork American River to Jenkinson Lake; (4) providing relief from permit condition 9 regarding maintenance of Caples Lake at specified levels for recreational purposes during the recreation season; and (5) providing relief from permit condition 12 regarding the bypass, release, and lake capacity requirements imposed by the Federal Energy Regulatory Commission (FERC) license for Project 184.
