NOTICE OF PETITION FOR TEMPORARY CHANGE INVOLVING THE TRANSFER OF UP TO 10,700 ACRE-FEET OF WATER FROM SOUTH SUTTER WATER DISTRICT TO STATE WATER CONTRACTOR AGENCIES UNDER LICENSE 11118 (APPLICATION 14804)

South Sutter Water District (SSWD) filed a petition on April 17, 2020, for temporary change with the State Water Resources Control Board, Division of Water Rights, to transfer up to 10,700 acre-feet of water pursuant to Water Code section 1725 et seq., under water right License 11118 (Application 14804). The transfer water would be made available at proposed additional points of rediversion by groundwater substitution through reservoir release of previously stored water from Camp Far West Reservoir and Camp Far West Diversion Dam under SSWD's License 11118. SSWD proposes to transfer the water from July 2020 through September 2020 to seven State Water Contractor Agencies: Dudley Ridge Water District, Kern County Water Agency, County of Kings, Palmdale Water District, Tulare Lake Basin Water Storage District, Santa Clarita Valley Water Agency, and Alameda County Water District. The proposed transfer would include the following temporary changes to SSWD's License 11118: (1) add the State Water Project's (SWP) Harvey O. Banks Pumping Plant and San Luis Reservoir as additional points of rediversion; (2) add a portion of the SWP's service area as shown on Maps 1878 – 2 and 3 under water right Application 5630 as an additional place of use; and (3) add municipal and industrial as additional purposes of use.

Pursuant to California Water Code section 1726(f), any interested person may file a comment regarding the petition. **Comments filed in response to this notice should be submitted to the persons listed below and must be received by 4:30 p.m. on May 27, 2020.**
