# ORDER APPROVING CHANGE IN AMOUNT OF DISCHARGE, PLACE OF USE AND PURPOSE OF USE OF TREATED WASTEWATER

### WHEREAS:

- 1. Treated Wastewater change petition WW-28 was filed by the Sacramento Regional County Sanitation District (District) on April 4, 1995 pursuant to Sections 1210 and 1211 of the California Water Code.
- 2. The change petition was filed with the State Water Resources Control Board (SWRCB) to obtain approval under Sections 1211 and 1700 of the California Water Code to change the place of use and purpose of use of treated wastewater.
- 3. During the last three years, the District's wastewater treatment plant has made an average dry weather discharge to the Sacramento River of about 140 mgd. District intends to reclaim up to 10 mgd of its treated wastewater. Upon approval of the petition District's discharge to the Sacramento River would be reduced by the amount of treated wastewater reclaimed.
- 4. The SWRCB has determined that good cause for the change(s) has been shown.
- 5. The SWRCB has determined that the petitioned changes do not constitute the initiation of a new right nor operate to the injury of any other lawful user of water.

### NOW, THEREFORE, IT IS ORDERED THAT:

- 1. The District's wastewater treatment plant discharges to the Sacramento River tributary to Sacramento-San Joaquin Delta in Sacramento County; within the SW% of SW% of projected Section 13, T7N, R4E, MDB&M.

  California Coordinate System: Zone 2, North 287,192, East 2,142,857.(0000001) (0000002)
- The District may reduce its discharge to the Sacramento River by reclaiming up to 10 mgd of treated wastewater.
- 3. The place of use of the reclaimed wastewater, as shown on a map on file with the SWRCB, is generally described as follows:
  - Within the Sacramento Regional Wastewater Treatment Plant's (SRWTP) property boundary.
  - The City of Sacramento's Bartley Cavanaugh Golf Course.

Laguna West, Lakeside, and Elliott Ranch South developments for irrigation of parks, schools, greenbelts, landscaped road medians, freeway interchanges at Interstate 5 with Laguna and Elk Grove Boulevards, and commercial properties. (0000004)
