
1 The above-captioned parties hereby petition the State Water Resources Control Board  
2 (“SWRCB”) to grant a 24-hour emergency extension of time for filing the testimony and  
3 associated exhibits of Roger B. Moore. The Board granted an extension earlier until noon on
