1 This request to change the Draft Order of Presentation for Part 2 is jointly filed by Save the
2 California Delta Alliance, et al. (Group 30), North Delta C.A.R.E.S. (Group 39), Patrick Porgans
3 (Group 40), and Snug Harbor Resorts (Group 41) (“The Parties”).

4 On January 4, 2018, the Board issued a Draft Order of Presentation and directed that any
5 comments on the Draft Order of Presentation should be submitted on or before January 11, 2018.
6 The Board also directed that, as per its customary practice, any requested change in the order of
7 parties should be worked out among the parties and any parties wishing to change order should
8 arrange to switch with other parties before making a request to the Board.

9 On the Draft Order of Presentation, Delta Alliance is listed as 12th, North Delta Cares is
10 listed as 20th, Porgans is listed as 21st, and Snug Harbor Resorts is listed as 22nd.

11 The Parties have met and conferred with each other and with other parties and request that
12 the Draft Order of Presentation be adjusted so that Delta Alliance switches with North Delta Cares,
13 Porgans, and Snug Harbor. Delta Alliance has seven witnesses while North Delta C.A.R.E.S.,
14 Porgans, and Snug Harbor together have six witnesses. The Parties believe that the amount of time
15 taken by Delta Alliance on the one hand and North Delta C.A.R.E.S., Porgans, and Snug Harbor on
16 the other hand, will be about the same. This manner of switching, therefore, should not change the
17 timing for, or inconvenience, any other party.

18 The Parties understand that it is impossible to predict with certainty how fast (or slow) the
19 proceedings will move. However, The Parties have used their best estimates and consulted with all
20 of their witnesses and believe that this adjustment will better match the timing of the Hearings with
21 the availability of their witnesses and will avoid any hardships or need for last minute requests for
22 any changes or orphaned hearing days or partial days. The Parties make this request well in advance
23 of their scheduled appearance times in an effort to contribute to an orderly and smooth process.

24 The requested final Order of Presentation would then be North Delta Cares 12th, Porgans
25 13th, Snug Harbor 14th, and Delta Alliance 22nd.
