By oral ruling from the bench on April 23, 2018, Hearing Officer Tam accepted into evidence without objection SCDA's Part 2 case-in-chief exhibits. Subsequently, staff approached Delta Alliance and requested a confirming list of SCDA's Part 2 case-in-chief exhibits.

That list is attached.

SCDA-200–224 were previously withdrawn and do not appear on the attached list.

In addition, by email on April 19, 2018, Delta Alliance transmitted to the Board an exhibit labeled scda-131 Errata. SCDA-131 Errata is the qualifications of witness Russel Ooms.
