24 I, Robert Granberg, declare as follows:

25 On August 31, 2016, the City of Stockton (Stockton) submitted to the California  
26 State Water Resources Control Board (SWRCB) exhibit numbers STKN-001 through  
27 STKN-022, which included my testimony (Testimony of Robert Granberg) as exhibit  
28 number STKN-010.

1 Inadvertently, my testimony (exhibit number STKN-010) at page 8, line 8,  
2 mistakenly referenced Stockton's exhibit STKN-014 instead of STKN-022. Exhibit  
3 number STKN-022 as submitted to the SWRCB on August 31, 2016 is a true and correct  
4 copy of Delta Diversion-DWSP Output Table, which, as described in my testimony,  
5 shows the amount of surface water diverted by the City of Stockton at its Delta Water  
6 Supply Project on the San Joaquin River, and treated, by month, in the  
7 years 2012-2106.

8 I declare under penalty of perjury under the laws of the State of California that the  
9 foregoing is true and correct.


