

## Chapter 3

# Indices of Commenters

---

The following indices list the comments received on the 2023 draft Staff Report, the July 2025 revised draft Bay-Delta Plan, the 2025 partially recirculated draft Staff Report, and the December 2025 revised draft Bay-Delta Plan. They are categorized by the type of commenter. Each letter and oral comment is given a “letter number.” They are then indexed by organization and commenter name within one of five categories:

- Federal agencies and elected officials and tribal governments.
- State agencies and elected officials.
- Local agencies and elected officials.
- Other governmental organizations and non-governmental organizations.
- Individual members of the public.

Readers should use these indices to identify the letter number or numbers associated with their submissions and then find the comments and responses in the comment response tables in Volume 3, Chapter 4, *Responses to Comment Tables*. A blank entry indicates that the information was not provided or was not legible or audible. If a name was not provided, it is indicated with “/”. Multi-signatory letters and multi-membership panel hearing presentations were assigned a single unique comment number. If these letters or panels came from multiple categories of commenters, the letter number appears in each applicable index table below.

Comments on the 2023 draft Staff Report were taken into consideration and the Staff Report was revised and partially recirculated in 2025. The comment period in which a letter was submitted can be determined from the letter number as follows: letter numbers less than 900 were submitted on the 2023 draft Staff Report, letter numbers between 900 and 1000 were submitted on the July 2025 revised draft Plan, and letter numbers of 1000 or greater were submitted on the December 2025 partially recirculated draft Staff Report and revised draft Plan. The Board has made every effort to respond to comments in a comprehensive manner but acknowledges that, due to the large number of comments, some responses to older comments may refer to prior iterations of the project. Common responses discuss the revised proposed Plan amendments as of the date of this Staff Report’s release.

Oral comments presented at the Staff Report hearings are indicated with an asterisk (\*). Slides presented at the hearings were included in the comment tables for the public hearing on the 2023 draft Staff Report, but were generally not included for the public hearing on the 2025 partially recirculated draft Staff Report. However, even if not represented in the comment tables, the whole of a presentation, including any slides, was considered in responding to oral comments. Similarly, exhibits within written comment letters (e.g., figures, tables, images) and attachments of documents that did not contain comments on the Staff Report (e.g., scientific journal articles, prior comments on other projects) were included in the comment tables for comments received on the 2023 draft Staff Report, but not for comments received on the July 2025 revised draft Plan, 2025 partially recirculated draft Staff Report, or December 2025 revised draft Plan. However, all components of written comment letters were reviewed and considered in responding to comments.
