# NOTICE OF VIOLATION

# DIVISION OF WATER RIGHTS INVESTIGATION OF MENDOCINO COUNTY ASSESSOR PARCEL NUMBER (APN) 032-224-10-00, 032-224-06-00, 032-225-22-00, and 032-224-21-00

David Oleary,

On September 19, 2024, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with California Department of Fish and Wildlife (CDFW) conducted a search warrant investigation of the properties referenced above. The purpose of the investigation was to observe the diversion and use of water occurring on the properties and to evaluate potential impacts to the watershed.

You are being contacted because you were identified as the property owner of the Mendocino County APNs 032-224-10-00 and 032-224-06-00 where you were allegedly irrigating cannabis with water diverted from a reservoir located on 032-225-22-00.

During the investigation, Division staff observed California Water Code (WC) and State Water Board, Cannabis Cultivation Policy (Policy) violations. Enclosed is the Division's Inspection Report (Report) for the properties that includes Division staff observations, alleged violations, and the corrective actions necessary for compliance with the WC and the State Water Board's Policy. The enclosed Report constitutes your third notice of the alleged violations, and this matter requires your immediate attention. The first Notice of Violations (NOV) was left with a copy of the search warrant on September 19, 2024, and detailed WC and Policy violations and corresponding corrective actions. The second notice was provided by email on November 6, 2024, which was a photo of the field NOV left at your property. After reviewing the inspection observations, photos, and

details of the cultivation operation, additional violations were assessed and included in the attached Inspection Report.
