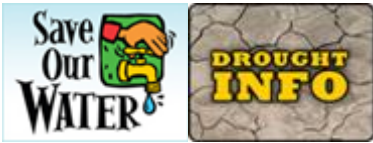
Mr. Arrache,

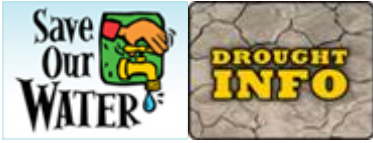
