Subject: Potential Water Transfer

Dear Mr. Somavarapu,

This letter serves as Byron Bethany Irrigation District's (BBID) official request for Sacramento Regional County Sanitation District's (SRCSD) consideration to transfer a minimum of 5,000 acre-feet up to a maximum of 10,000 acre-feet of SRCSD's treated wastewater that is discharged in the Sacramento River. BBID is a multi-county public water agency located within the legal Delta and serves land in the Byron-Tracy area. (See attached map of the District's service area.)

BBID expects the State Water Resources Control Board (SWRCB) to issue Curtailment Notices to pre-1914 water right holders within the next two-four weeks. The supply purchased by BBID would be utilized to meet demands of the community of Mountain House, Mariposa Energy Center, Byron Airport and meet certain agricultural demand.

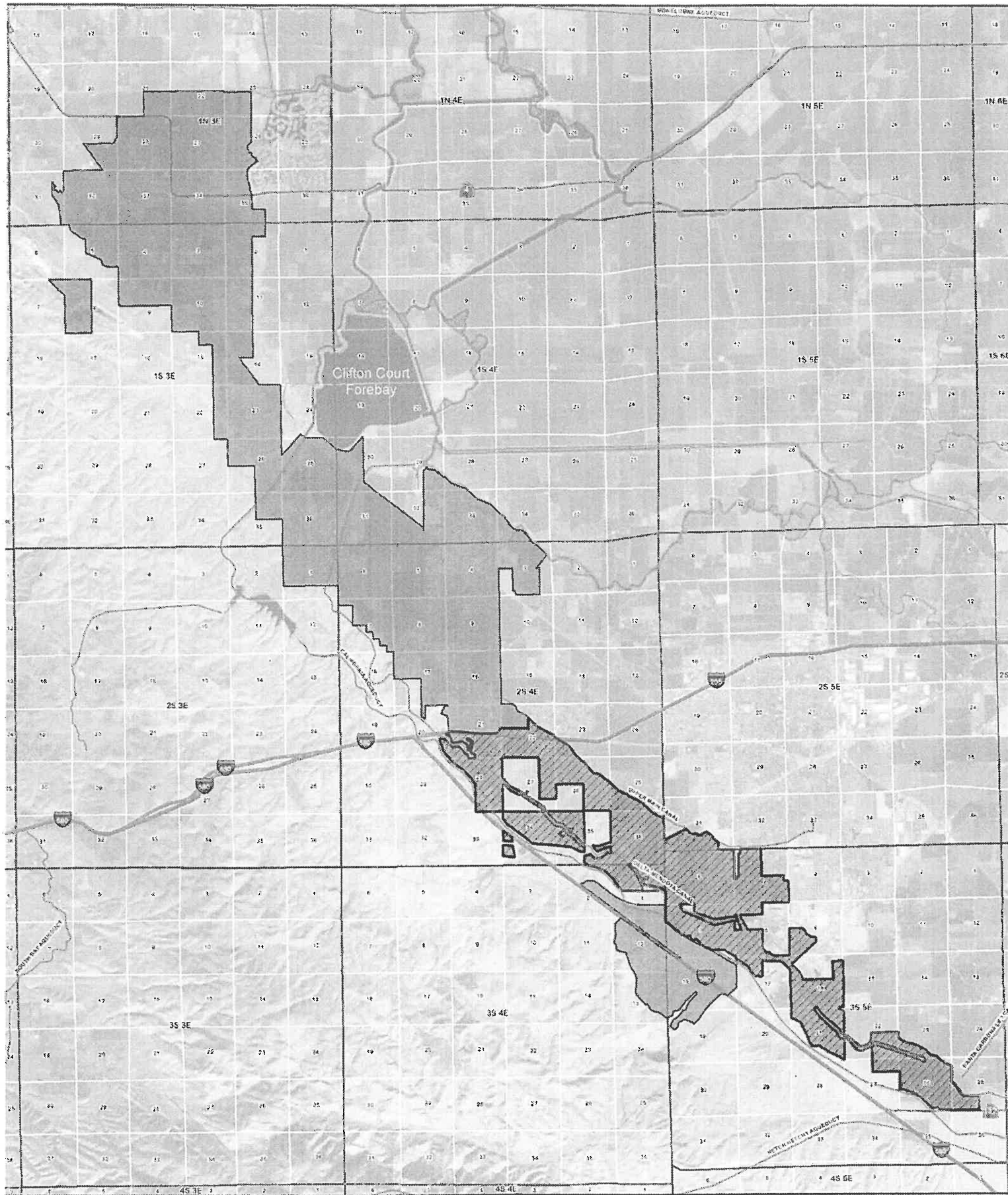
BBID is aware that SRCSD will need to file a Temporary Urgency Permit with the SWRCB. BBID is willing to share and/or cover the costs associated with the permit and purchase the water at \$400 per acre-foot.
